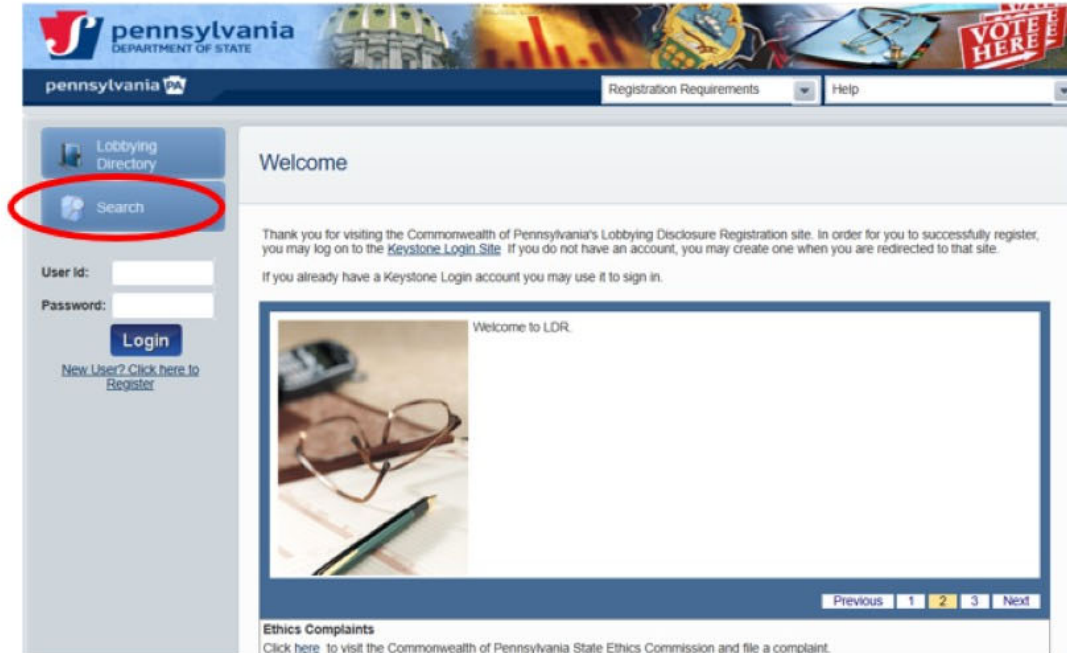


TRACKING LOBBYING ACTIVITY IN PA

A Step-by-Step Guide to Following Lobbyist Registrations and Expenditures

1. Visit the Department of State [Lobbying Disclosure Registration Site](http://www.palobbyingservices.pa.gov) (www.palobbyingservices.pa.gov)

2. Click on “Search”



3. Type the name of the lobbyist firm you wish to search for in "Firm Name" area.
4. Click "Search".
5. Several results will usually appear. Click on the link that says "Registration" beside the name that most closely resembles the name you are searching for.

6. A **Summary** containing several pertinent details appears, along with the option for a “Printer Friendly Version”.

A registration status listed as “Completed” is current. A status listed as “Terminated” means that the firm/individual is no longer active.

The “Lobbying Commenced” date shows the first date the firm/individual registered as a lobbyist.

The “Nature of the Business of the Firm” indicates if the firm is strictly lobbying, is also providing legal counsel, or other business.

7. The **Principals** section lists every company the firm is associated with, along with the dates they began lobbying for the company and a termination date, if applicable.

As an example, listed among the companies represented by Buchanan Ingersoll & Rooney is Dominion Voting Systems, Inc. You can see that the firm began lobbying for Dominion on 1/24/2017 and no end date is listed, which means that Dominion is still an active client.

8. Further below is a list of **Lobbyist(s)** associated with the firm.

As shown, many listed are no longer actively lobbying for the firm, indicated by their end date.

Some lobbyists, like Mr. Lafe Metz found below, might leave for a period and return. They are usually listed more than once.

Active lobbyists, like Carrie Lewis DelRosso, former candidate for lieutenant governor, do not have an end date listed.

- Any associated **Political Action Committees** are found listed at the bottom of the summary.

When digging through campaign finance reports, you will want to search for these PACs to see who they are giving money to. You will also want to search campaign finance reports for clients that may be related to a proposed piece of legislation and any active lobbyists that represent them.

- Lobbyists do not always work for just one firm, nor do they tend to represent every client listed for a lobbying firm. It is important to proceed with the next layer and search the individual lobbyist

Enter the “Lobbyist First Name” and “Lobbyist Last Name” in the respective fields and click “Search”.

11. Several results will again appear, with the closest matching name at the top of the list. Click on "Registration".

12. Much like with a lobbying firm, a Summary for the lobbyist appears with pertinent details including their lobbying commencement date and status.

Additionally, individual lobbyist summaries will contain a yes/no question regarding their current attorney status as well as a **Photograph**.

13. Listed further below are clients of the individual lobbyist, the lobbying firm or firms the lobbyist works for, and any political action committees or candidate committees the lobbyist is associated with.

In this example, you see that DelRosso is currently representing Dominion Voting Systems, Inc., as indicated by lack of a termination date, which she began on 5/31/2023.

Buchanan Ingersoll & Rooney is the only lobbying firm DelRosso has been associated with, and she is actively lobbying for the firm, as indicated by the omission of an end date.

DelRosso is not involved with the firm's PAC, as it not listed here.

14. Finally, you can perform a search for any Principal or Client that may have hired a lobbyist to represent them in PA. Type in the name of the company in the “Principal Name” field and click “Search”.

After clicking “Registration” next to the closest matching name, another summary will appear.

Additionally, every lobbyist associated with the principal is listed, including their effective dates.

Any lobbying firm that the company had done business with is listed below that.

If the company is affiliated with a PAC, that is also listed.

Unique to the company listing are questions pertaining to association/organization.

TIP: When beginning your lobbying search for the first time, start by entering the name of your county in the “Principal Name” field. You can view additional information by clicking on “Registration” or access monies spent by the client by clicking “Expenses”.

Next, perform a search in the same field for “township”, “boro”, “city”, and “school district” and look for results applicable to your county.

From there, you can submit right-to-know requests for contracts, check meeting minutes to ensure the fees were covered in a public meeting, and advocate for the termination of services and cease payment.
